SECTION 5 – Conditions Applicable to all Permits

- Approval depends, to a large extent, on the attitude of the neighbours.
- I Runs, yards, pens, sheds and kennels etc. will need to meet all conditions of the Local Law.
- Failure to maintain conditions, or the receipt of complaints from neighbours, could result in termination of permit.
- **All applications are subject to an inspection by an authorised officer.**
- The application fee is non-refundable.
- The permit expires on 9 April each year and must be renewed annually.

SECTION 6 – Conditions specific to Cat/Dog Permits

- All dogs and cats on the property must be registered with the City of Monash.
- All dogs must be under control or confined to your property at all times.
- The permit is only applicable to the original animals, i.e. if any of the extra dogs/cats pass away, they must not be replaced (Exhibitors/ Registered breeders excepted).
- All applications are subject to an inspection by an authorised officer.
- Once a permit is granted for a specific number of dogs/cats, no further increases in number will be allowed (i.e. If you have a permit for four cats, you must not acquire a fifth animal without written consent from the Local Laws Department).
