

Waste Collection Services

Application for Special Consideration on Bin Fees

Monash Council offers additional waste and recycling services free of charge to residents under specific circumstances. Council has written guidelines for these special circumstances, and they are primarily to encourage further recycling as much as possible. Special Consideration may be given to residents with medical reasons, large families with financial constraints or households with two or more children in nappies.

Who is eligible?

Residents with a medical condition that generates additional waste and/or recycling, large families (6 or more people in household – not including extended families) with demonstrated financial hardship and households with two or more children in nappies are eligible to apply.

How can I apply?

Complete the application form overleaf and return it to Council as directed on the form. Include the following supporting documentation:

- Medical condition: include a statement from your Doctor advising that treatment of the specific condition involves significant additional waste for the household.
- Financial hardship: supply a copy of your current Centrelink Pension card and/or Health Care Card.
- Two or more children in nappies: supply a copy of maternal child health book (MCH green book), with children's dates of birth, names and address (other information can be omitted).

How will my application be processed?

Your application for Special Consideration will be assessed based on the information you provide on your application form against the criteria above and supporting documentation.

What can I do if my request for Special Consideration is denied?

If your application is unsuccessful, we will let you know the reason why and you may choose to resubmit your application with further information or documentation. You can still select to have additional services, but you will be required to pay any applicable charges for those services.

What if my circumstances change i.e., my child is no longer in nappies, or I move house?

One of the conditions of Special Consideration requires that you notify Council if your circumstances change, this includes moving from your current premises or a variation in your health/financial/family status. This includes if your child/children no longer wear nappies. Misuse of this service, such as not notifying us of circumstance changes or repeat contamination, may result in withdrawal of the service. Special considerations are approved for a 24-month period only and are reassessed after this time. Should you require an extension to your Special Consideration services you will be asked to re-apply. All bins supplied by Council must be used in accordance with the "Conditions of Service and Supply" document available from Customer Experience or at www.monash.vic.gov.au/bin-issue
